

LibDib 101: What Does LibDib Do?

- LibDib is a licensed wholesale distributor in 9 states.
 - o (CA, NY, NJ, CT, IL, FL, MD, CO and WI).
- LibDib is also the technology behind a **selling division within RNDC**.
 - o (GA, IN, LA, OK, TX and more states coming soon).
- The goal of the LibDib platform across both models is to provide **any Maker** with three-tier access to a market, whether it's one case at a time or a pallet drop.
- LibDib's business model is **different from other distributors**; we do not have trucks, sales reps or warehouses full of inventory. We utilize a 'Just-In-Time' inventory model where common carrier and distributor partners get products to where they need to go, compliantly. **Costs vary by market** based on the model and fulfillment charges.



LibDib 101: Who can work with LibDib?

- All Makers are welcome!
 - Wineries, Distilleries, Importers
- Makers must be legal!
- Foreign Brands: We work with your importer as they hold the license.
- Rectifiers, other producers making your product:
 - RULE OF THUMB: We pay the licensee....who is that entity and then what is your deal with them?



What do I need to Work with LibDib?

1. TTB Basic Permit

2. Home State License

3. Permit/Licenses required by EACH state you are doing business in

4. FedEx Alcohol
Shippers Agreement



Shipping

- LibShip for the WIN!
 - Compliance
 - Tracking
 - Bill Back for First Leg
- How much does it cost?
 - o 6 Pack: \$15-\$20
 - o 12 Pack: \$20-\$30
- Need to have:
 - FedEx Alcohol Shipping Agreement
 - <u>LibShip Certificate</u>
- SHIP SAFE!!! #1 challenge with shipping is breakage when things are not shipped safely.
